### **WAIVER OF LIABILITY AND RELEASE AGREEMENT**

#### **ACKNOWLEDGEMENT OF RISKS**

The Undersigned understands that there are certain dangers, hazards and risks (foreseen and unforeseen) inherent in attending and participating in the Summer Camp, including, without limitation, risks related to use of equipment and facilities, personal safety (including risks of minor, serious or mortal personal injury) and risks of property damage.

Participants who develop any covid related symptoms will be isolated, receive medical care and parents will be asked to pick them up from the camp.

In recognition of the dangers, hazards, and risks (foreseen and unforeseen) associated with attending and participating in the OUTLIFE Outdoor Summer Camp, the undersigned confirms that the participant is physically and mentally capable of attendance and participation in all activities and use of all equipment associated with the Summer Camp. The participant is willingly and voluntarily attending and participating, and the Undersigned agrees that they and the participant shall assume all dangers, hazards, and risks (foreseen and unforeseen) inherent in, arising from or related to the participant's attendance and participation in the OUTLIFE Outdoor Summer Camp. Due to any unavoidable circumstances or any natural calamity Outlife or any other person associated with the same shall not be responsible for any claim or compensation.

It is the express intent of the Undersigned that this Agreement shall bind the undersigned, any other parent, the participant, the participant's family, estate, heirs, administrators, personal representatives or assigns. The Undersigned acknowledges that they have read and understand this document and the RELEASE AND HOLD HARMLESS provisions. The Undersigned agrees that this Agreement shall be construed in accordance with the laws of India, without giving effect to the conflict of laws provisions thereof, and that the Jurisdiction of Hyderabad, India shall be the forum for any lawsuits filed under or incident to this Agreement. The terms and provisions of this Agreement shall be severable, such that if a court of competent jurisdiction holds any term to be illegal, unenforceable, or in conflict with any law governing this Agreement the validity of the remaining portions shall not be affected thereby, and each and every term and condition of this Agreement shall be valid and enforced to the fullest extent and in the broadest application permitted by law.
